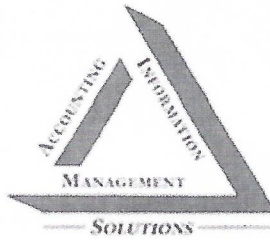

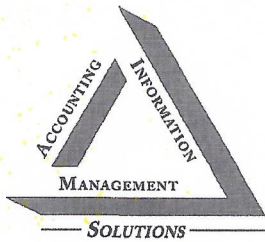

Dear Mr. President:

Thank you, Chief of Staff Ron Klain, Vice President Kamala Harris, Senior Advisor Cedrick Richmond and United States Senators for the 117th United States Congress, including Senate Majority Leader Charles Schumer, Senate Minority Leader Mitch McConnell, Senate Judiciary Chairman Dick Durbin, Ranking Member Charles Grassley, and Member of the Senate Judiciary Committee, for acknowledging my call-for-action letters [with confidential actionable intelligence] filed between **May 4, 2009 and August 19, 2021** with the Presidents of the United States [White House#101595], federal lawmakers, United States Attorney Generals [DOJ/WF#2181254] and Inspector General Community [USDOT/OIG#10IH-A42-I-000] under the **Title VI of the Civil Rights Act of 1964** and other enacted laws, and also acknowledging the unfinished work reported in the **Minority Report – The Extraordinary Discovery [MR TED Report]**, which was prepared and completed under the **Doctrine of “Completed Staff Work.”**

In the wake of implementing **“Operation Secondary Protocol,”** I write you, White House Officials, United States Senators, United States Attorney General Merrick Garland, FBI Director Chris Wray and United States Department of Justice Inspector General Chief/Council of Inspectors General on Integrity and Efficiency [CIGIE] Chairman Michael Horowitz today with wonderful news that we have deployed our ground team to complete our purpose-driven mission, the **\$5.250 Trillion Dollar/5-Year Greater Urban Revitalization Project**, augmented into four [4] phases [Mass Recovery, Acquisition Reform in Federal Programs, Economic Inclusion and Infrastructure &



**Restoration]** that will help resolve the “**Top Challenges Facing**” the inspector general community, their federal agencies and severely flawed federally-funded programs, help uplift African-Americans living in America’s inner-cities, help resurrect, strengthen and empower underrepresented [overlooked and underserved] black communities across the United States Regions and help save the American Taxpayers billions of dollars in a more efficient, more accountable and more transparent government, while forever cementing your legacy in the **Post-Civil Rights Movement** and forever securing your footprint in the greatest economic revolution in American history, especially after you signed into law the \$1.2 trillion historic bipartisan infrastructure bill on **November 15, 2021**.

Sir Winston Churchill, former Prime Minister of the United Kingdom, once said, “*those that fail to learn from history are doomed to repeat it.*” Since releasing the unprecedented but damning **Kerner Report** on **February 29, 1968**, the United States government has not done enough in the past five decades to resolve a system strategically and specifically designed by white supremacy to do enormous harm to black communities in the United States of America. Established over fifty-four years ago on **July 28, 1967** by the 36<sup>th</sup> President Lyndon B. Johnson in **Executive Order 11365** to investigate the causes of race riots in US cities in the mid-1960s and provide recommendations for the future, **The National Advisory Commission on Civil Disorders**, an 11-member Presidential Commission known as the Kerner Commission, after its chair, Illinois Governor Otto Kerner Jr., released the **1968 Kerner Report** that unveiled a groundbreaking federal study raising awareness of the negative effects of segregation, discrimination on black urban communities and black frustration due to the lack of fair housing, education, social services, economic opportunities, and a racist media who played a major role in racial violence against black people by serving as cheerleaders for white supremacy in news coverages.

The **1968 Kerner Report** validated and confronted the indisputable truth on inhumanity, systemic racism, poverty, economic inequality, and social injustice in the United States of America, provided disturbing revelations on the stranglehold of white supremacy, shed light on the race riots in America’s inner-cities, and who was actually responsible – white supremacy, bad policing practices, flawed justice system, unscrupulous consumer credit practices, inadequate housing, anticompetitive business practices, discriminatory employment practices, voter suppression, and other culturally embedded forms of racial discrimination all converged to propel violent upheaval on the streets of black neighborhoods in US cities, north and south, east and west. Evidence showed violence often worsened when black unrest arose and inadequately trained police officers and National Guard troops entered affected neighborhoods.

The presidentially appointed panel, led by Chairman Kerner, New York City Mayor John Lindsay [Vice Chair], United States Senator Edward Brooke (R-MA), United States Senator Fred Harris (D-OK), United States Congressman James Corman (D-CA), United States Congressman William McCulloch (R-OH), Litton Industries Founder Charles Thornton, NAACP Executive Director Roy Wilkins, United Steelworkers of America President I. W. Abel, Atlanta Police Chief Herbert Turner Jenkins and Kentucky Commissioner of Commerce Katherine Graham Peden, reported, “*white society is deeply implicated in the ghetto. White institutions created it, white institutions*



*maintain it, and white society condones it,”* referencing to the lack of affordable housing, severely flawed education system, economic disparities, unenforced anti-discrimination laws and social unrest following police misconducts.

The nation, the Kerner Commission warned, was so divided that the United States was “*moving toward two societies, one black, one white—separate and unequal.*” In fact, long standing public policies created the urban decay, disparity, and poor conditions, and it would require public policies to eliminate them. Unless these conditions are remedied, the Kerner Commission cautioned that the country faced a “*system of 'apartheid'*” in its major cities. Thus, in pursuit of the “*American Dream,*” the Kerner Commission proposed an aggressive government spending to provide equal opportunities for African-Americans, including helping create jobs and helping African-Americans gain access to capital for homeownership and business, but President Johnson, who four years earlier signed into law the landmark **Civil Rights Act of 1964** on **July 2, 1964**, acknowledged, disparaged and disapproved the recommendations by the Kerner Commission, the same panel he personally appointed six [6] months earlier.

At a time today when systemic racism, discrimination, poverty, economic inequality, and social injustice are once again the focus of a national protest movement, the **1968 Kerner Report** revealed a bitter truth in American history. Upon acknowledgement by reading the entire **462-page Kerner Report**, which is, in fact, an official US Government document, our Bipartisan US Congress, who sponsored, endorsed and unanimously passed several key bills that the 44<sup>th</sup> President Barack Obama signed into law between 2009 and 2016, would agree on the factual, historical and indisputable information in the **Kerner Report**, agree the **Report** can no longer be overlooked, and agree that the American people do not need any more shameful disparity studies when we know what the facts are. Therefore, we know precisely what needs to be done to rectify and eradicate systemic racism, discrimination, poverty, economic inequality, and social injustice in America, and we know exactly when and where to start to open new opportunities to help uplift African-Americans, and help resurrect, strengthen, and empower black communities in America.

Almost Fifty-four years after the unprecedented but damning **1968 Kerner Report** became public, African-Americans are confronted today with similar concerns, including high crimes, poor quality of living and limited access to affordable housing, health care, capital, quality of education, good paying jobs with benefits, public safety, and public services. The **2019 Federal Reserve Racial Disparity Studies** confirmed the damning statistics that African-Americans, as a group, are free falling in comparison to other diverse ethnic groups, including Whites, Hispanics, Asian, American Indian, Alaska Native, Native Hawaiian and Pacific Islander. Unless public policies are amended and rules of laws are enforced, African-Americans will continue to free fall. With our strategic action plan, renewed commitment and Herculean efforts, African-Americans would neither have to feel like second-class citizens living in America nor have to compromise themselves, beg or wait in line for handouts because of the existing laws under the United States Constitution [**including the Title VI of the Civil Rights Act of 1964**], abundance of untapped resources and millions of ambitious black professionals seeking opportunities to solve **America's Top Challenges**.



Today, we have the blueprint with the right solution to open new and existing opportunities for African-Americans that will transform and transcend underrepresented black communities across the US Regions. In preparation to complete all four phases – **Phase I [Mass Recovery]**, **Phase II [Acquisition Reform]**, **Phase III [Economic Inclusion]** and **Phase IV [Infrastructure & Restoration]**, we are in the process of assembling the most diverse, best-in-practice and most respected Executive Team [Chairperson, Board of Directors, Secretary, Counsel, Chief Executive Officer, Chief Financial Officer, Chief Operating Officer and Advisors], law firms, accounting firms and private equity investment firms [see list] to contribute their talent, working knowledge and experience to our purpose-driven mission, complement and balance our ground teams, collaborate with the White House, federal lawmakers and Attorney General, acknowledge the top challenges facing the local, state, federal and corporate programs, comprehend the blueprint and consent to the important role that each will play in overseeing the **Greater Urban Revitalization Project** and **STEAM [Science, Technology, Engineering, the Arts and Mathematics] Endowment Foundation [pending 501(c)(3) organization]**, including its programs and grantmaking strategies; budgets, expenditures and appropriation policies and guidelines; and investment strategies, allocations and performance.

In a continuous show of a strong bipartisan support in the United States Congress by enacting new laws in the wake of your **Executive Order 13985** issued on **January 20, 2021** to “*advancing racial equity and support for underserved communities through the federal government*,” your call-for-action for investors, lawyers and accountants to “*help reduce the racial wealth gap in the United States*” during your visit to Tulsa, Oklahoma on **June 2, 2021** to acknowledge the hundred year anniversary of the Tulsa race massacre, and your most recent call-for-action, “*delivering economic justice for black Americans*,” on **October 21, 2021** before the Martin Luther King Jr. Memorial, we are all in this together to help fix the United States economy, restore public trust in federal agencies, eradicate the systemic racism in federal agencies and their severely flawed federally-funded programs, amend federal Disadvantage Business Enterprise programs [by leveling the playing field and opening new and existing business opportunities for the millions of black-owned businesses], eliminate anticompetitive practices and strengthen the anti-fraud efforts in federally-funded programs uncovered in the **MR TED Report**, while fighting for the economic justice, social justice, and equity opportunities for African-Americans living in the United States of America.

In all three call-for-actions, “*advancing racial equity and support for underserved communities through the federal government*, *help reduce the racial wealth gap in the United States* and *delivering economic justice for black Americans*,” we fully intend in our purpose-driven mission to continue collaborating with you, Senior White House Officials, federal lawmakers, Attorney General Garland and Inspector General Community to strengthen the anticompetitive and anti-fraud efforts, implement the massive recovery efforts, amend acquisition reform in federally-funded programs for Disadvantage Business Enterprises [DBEs] to change the landscape by leveling the playing field for DBEs, gain equal access to hundreds of billions of dollars in federal resources [contracts and grants] by averting decades of missed opportunities for DBEs that amounted in trillion of dollars lost in government and corporate



contracts, diverting annually hundreds of billions of dollars back into government and corporate programs and forever changing shameful trends in various disparity reports to favorable trends by providing DBEs sufficient training and relevant information [roadmaps] for success in government and corporate programs, opening new and existing opportunities for DBEs to participate and succeed in local, state, federal and corporate programs, and monitoring, producing, and submitting timely and fact-based progress reports to you, federal lawmakers, Attorney General Garland, IG Chief/CIGIE Chairman Horowitz and Government Accountability Office Comptroller General Gene Dodaro that would, in fact, improve our government programs and save American Taxpayers billions of dollars.

With great responsibility in responding to your call-for-action, we stand on the shoulders of great giants and countless heroes from the **Civil Rights Movement**, who fought courageously on the frontline, risked their lives, endangered their families and jeopardized their careers to pave the way for us to have this extraordinary opportunity today to serve both the federal government and the American people by implementing “**Operation Secondary Protocol**” and completing our purpose-driven mission in the fight against inhumanity, systemic racism [including anticompetitive practices in federal programs], poverty, economic inequality and social injustice in America.
